Reform & Abolition: CLOSING JAILS AND PRISONS

The abolitionist movement to close jails and prisons doesn't just end when elected officials decide to enact reform. Activists and carceral system reform advocates in St. Louis and New York City say that even when one jail or prison closes, there's often another issue that arises or a contingency plan that can get in the way of reform efforts. With activists now in the seat of power in St. Louis and across the country, prison abolitionists are focusing their efforts in ensuring the system that leads people to being incarcerated changes. Many activists say that this is a harder battle to fight, pointing out that even when reforms are made to the criminal legal system, it adjusts itself to continue the incarceration model. <u>Critical Resistance notes</u>, "As we work to dismantle incarceration in all its forms, we must resist common reforms that create or expand cages anywhere, including under the guise of 'addressing needs' or as 'updated' replacements. Jails and prisons deprive communities of resources like medical and mental health care, transportation, food, and housing. In our fights, it is critical to uplift and strategically contribute to movements led by imprisoned people, both to address pressing conditions and for abolition. In all decarceration strategies, we must utilize tactics that will improve life for those most affected and make space to build the worlds we need." We can see reforms which aid in abolitionist goals of shrinking the prison industrial complex in, for example, #CLOSERikers' call to <u>#buildCOMMUNITIES</u> which would both close Rikers then divert resources systematically to spaces such as public health, housing, employment & economic development, education, community programs & services, and conflict transformation.

We call for the closure of the Medium Security Institution, better known in St. Louis as the Workhouse, an end to wealth based pretrial detention, and the reinvestment of the money used to cage poor people and Black people into rebuilding the most impacted neighborhoods in this region."

"For decades, Rikers Island has been marked by violence and corruption. Stories regularly emerge documenting the abuse, brutality, and death in the institution. The #CLOSErikers campaign was formed in 2016 to break political gridlock and achieve solutions guided by directly impacted communities." Sign the petition to close Rikers without opening a new jail.
