REFLECTION QUESTIONS:

Do you think running on reform of the criminal legal system helped you stand out from the other candidates? And do you think it's enough of a motivating issue to help you win in November?

I want to talk about how the political climate plays into getting reform enacted. In 2020, we saw high-profile cases involving the unjust killings of members of Black and Brown communities. How much does the political climate play into enacting reform?

To borrow a line from Laura Coates, we have "legal system aspiring to be a justice system." Are you encouraged that people seem to now want to take on this issue? And what do you think is the next level of reform? What do you hope we're talking about 25 years from now?

The Impact of Elections on Reforming the Criminal Justice System

The effort toward reform of the criminal justice system is driven by grassroots organizations across the country, but long-lasting reform on the local, state, and federal levels starts at the ballot box. Whom we decide to elect as Judges, District Attorneys, and Congressmen are vital in representing, instilling, and upholding the legislative change we need to see.

Over <u>97% of cases in the federal criminal justice system are resolved with plea bargains</u>. That's less than 3% of defendants taking advantage of one of their most important constitutional rights. According to the National Association of Criminal Defense Lawyers <u>(NADCL)</u>, "As trials and hearings decline, so too does government accountability. Government mistakes and misconduct are rarely uncovered...Moreover, the ease of conviction can encourage sloppiness and a diminution of the government's obligation to fairness."

As expressed through <u>Forum</u> by Michigan's Supreme Court Chief Justice, Bridget McCormack, "Although ethical constraints limit the form of their advocacy, effective law reform depends on judges' contributions and they are ethically obligated to improve the judicial system over which they preside." Understanding the background and platforms of judges up for election, or re-election help to make more informed decisions on who is aligned with criminal justice reform, and who may be influenced by <u>prosecutorial</u> <u>bias</u>. "Courts have explained that bias is a favorable or unfavorable opinion that is inappropriate because it is not deserved, rests upon [the] knowledge that the judge should not possess, or because it is excessive." as defined by <u>Dallas Criminal Lawyer Robert Guest</u>.

<u>Santana Deberry</u> served as the District Attorney of Durham County, NC in 2018 and is currently running for re-election uncontested. "The real power that the prosecutor has is in discretion...It says, as a prosecutor, as an elected prosecutor, I am the stand-in for my community and accountability for my community."

Running for 2022 Superior Court Judge in Los Angeles, CA, <u>Carolyn "Jiyoung" Park</u> shares, "The issues that we're confronted with, they didn't pop up overnight...It's going to be a multi-pronged solution. Judges are just a small part of that, but a very important part of the solution. When they do get in front of a judge, will that defendant have a judge that is fair?"

<u>Maxwell Alejandro Frost</u>, a running Democratic candidate for the House in Florida's 10th Congressional District, adds, "So we've been very honest in our campaign...promising what I'm going to fight for, how hard I'm going to fight for it...Because it's not about me fighting for the community. It's about me fighting with the community to make it happen."
